

Privacy Policy

This Privacy Policy describes how PrimeDelta Inc. (“PrimeDelta”, “we”, “us”, or “our”) handles personal information that we collect through our digital properties that link to this policy, including the website primedelta.finance, along with all associated websites, domains, and subdomains of PrimeDelta (collectively, the “Website”).

PERSONAL INFORMATION WE COLLECT

Information you provide to us

Personal information you may provide to us through the Website or otherwise includes:

- Contact data, such as your first and last name, email address, mailing address, professional title and company name (if applicable), and phone number.
 - Communications data, such as your messages, inquiries, and interactions with us through the Website, social media, email, or other channels.
 - Research data, such as your responses to surveys that we might ask you to complete for research purposes related to our business.
 - Marketing data, such as your preferences for receiving our marketing communications and details about your engagement with them.
 - Profile data, such as your blockchain or cryptocurrency address that you may need to use certain features on the Website.
 - Payment data, including your cryptocurrency address or other payment details required to complete transactions.
 - Technical data, such as your blockchain-based wallet address used to access certain services on the Website.
 - Other data, not specifically listed here, which we will use as described in this policy or as otherwise disclosed at the time of collection.

Third-party sources

We may combine personal information we receive from you with personal information obtained from other sources, such as:

- Public sources, including government agencies, public records, and social media platforms.
 - Data providers, such as third-party information services and data licensors that help us operate the Website.

Automatic data collection

We, our service providers, and our business partners may automatically collect certain information about you and your interaction with the Website:

- Device data, such as device type, operating system, browser, IP address, unique identifiers, and approximate location.
 - Online activity data, such as pages viewed, time spent on each page, referring websites, navigation paths, and engagement metrics.
 - Communication interaction data, such as whether you open or click links within our emails.

Cookies and similar technologies

We use cookies and related technologies to operate and improve the Website. These include:

- Cookies (session, persistent, first- and third-party) to record preferences and login status.
- Local storage technologies (e.g., HTML5) to store data locally.
- Web beacons or pixel tags to track email engagement or site analytics.

We may use cookies to enable technical operations, enhance functionality, and analyze usage patterns.

We currently do not respond to “Do Not Track” signals.

HOW WE USE YOUR PERSONAL INFORMATION

1. Website delivery and operations

To provide, operate, and improve the Website and our business; communicate with you about updates or support; personalize your experience; and respond to inquiries or feedback.

2. Research and development

To analyze and improve the Website and create aggregated, anonymized, or de-identified data for lawful business purposes.

3. **Marketing**

To send you marketing communications about our services or partners. You can opt out of marketing communications at any time (see “Your Choices” below).

4. **Compliance and protection**

To comply with laws, enforce our Terms of Use, protect our and others’ rights and safety, audit compliance, and prevent fraud or abuse.

5. **With your consent**

In cases where we request your explicit consent for data collection, use, or sharing.
